The attached *County HAVA Allotment and 5% Matching Requirement* table is being provided to you to help identify for you the portion of the HAVA Funds that require a county match in order to receive such funds. For your information, all of the voter education and poll worker training allocation is subject to 5% matching and a portion of the voting system allocation is subject to 5% matching.

Local match funds are necessary in order for county boards to access the voter education and poll worker training funds or the portion of the voting systems funds subject to matching.

It is important to note that this chart does not account for the Plan B purchases that were made and the fact that the State Board of Elections has already paid the county board 5% match on the completed Plan B purchases.
